California's historic preservation community is coming to your doorstep! The California Preservation Conference (May 15 to 18) is a unique opportunity to participate in activities that are educational and entertaining, and to meet new friends who share your interests.

The program is loaded with special tours, educational workshops, and events exploring preservation and its essential role in sustainability, economic development and community character. You can select individual events that appeal to you most, or immerse yourself by registering for the whole conference. If you volunteer to help out at the conference, you get an inside look as well as some free benefits.

The free plenary session on Monday morning features the new President of the National Trust for Historic Preservation, Stephanie Meeks. The program takes place at historic Barnum Hall (at Santa Monica High School) and includes the winning entries to the 2011 Youth Film Competition (see information on p7).

Three-Minute Success Stories (Monday night) is traditionally one of the most popular events of the conference, presenting compelling preservation stories with drama, humor and a touch of vaudeville. The stage at the historic Santa Monica Bay Woman's Club will provide an ideal venue.

Special tours created for the conference will showcase the historic, architectural and cultural treasures of Santa Monica and the region. You can explore Modernist architecture in the City and Santa Monica Canyon; tour the Adamson House in Malibu and learn about Malibu tile; explore film locations in the Santa Monica

Protection for Marquez Cemetery Expanded

The historic rancho-era Pascual Marquez family cemetery in Santa Monica Canyon will be more visible to the public in the future, thanks to recent decisions made by the City of Los Angeles. Ten years ago, LA granted Historical Cultural Landmark status to the cemetery on San Lorenzo Street, just off of Channel Road.

Unfortunately, the landmark application included only the area of the cemetery located within the 1926 adobe wall commissioned by Santa Monica Land and Water at the time of the subdivision of the Roman Marquez portion of the rancho. A small four foot easement was granted across the land lying between the cemetery wall and San Lorenzo Street (which was named after the wooden statue of San Lorenzo placed in a niche in the adobe wall). In later years, a confirming recognition of this easement involved significant litigation.

Last April, the land in front of the cemetery wall was sold. When the new owners began construction of a house on that land, surviving members of the Marquez family asked the City of Los Angeles to expand the boundaries of the landmark.

Shotgun House Design Approvals Granted

Plans for the relocation and rehabilitation of the Shotgun House continue to move forward after another milestone was recently reached. The Landmarks Commission and the Architectural Review Board, meeting jointly, approved our project with the following conditions:

- The house will ultimately be painted a creamy white rather than a "pure" white, which the Landmarks Commission believed was too modern.

- The sign outside the house will be reduced by 25%, while keeping its original style and proportions, in response to a concern by the Architectural Review Board.
- We will add additional landscaping along the west end of the building and the south side of the trash enclosure to soften the appearance.

Overall, every Commissioner and Board member indicated wholehearted support for our project. Next steps include an application to the California Coastal Commission for its approval which should be the last discretionary approval necessary before applying for a City building permit. The last two steps are estimated to take six to nine months.

Given this recent progress, we will be stepping up our fundraising efforts in the next 18 months. You'll be hearing more about this and how you can participate!

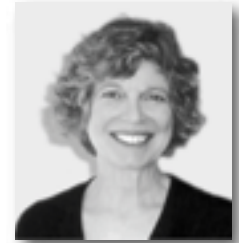

With support from the Cultural Heritage Commission, Los Angeles City Councilman Bill Rosendahl, members of the Marquez/Reyes Rancho descendants' family, local and state historic societies, and friends and neighbors, an agreement was reached with land owners Fred Marcus and Davida Rochlin. Marcus and Rochlin would sell the northern portion of their lot for less than market value and donate the balance of the value of the land to the non-profit La Senora Research Institute; cemetery supporters are now planning their fundraising efforts.

Supporters envision replacing the current wooden fence with a more appropriate iron fence that will allow the public to see the

cemetery wall with its niche containing the statue of San Lorenzo. "They will remain visible forever to the public from the street" said Ernesto Marquez, great great-grandson of Francisco Marquez and Ysidro Reyes, who were jointly granted the 1839 Mexican Land Grant Rancho Boca de Santa Monica.

Ernesto Marquez said, "The extended Marquez/Reyes family is overwhelmed with gratitude for all of our friends, cemetery neighbors, and supporters who sent letters and good wishes, and who made the trek to downtown LA to testify on our behalf. Please know that the Marquez/Reyes family has grown by the hundreds in the space of a year [because] all of you are now family and part of the history of the Rancho Boca de Santa Monica."

Volunteer Profile:

Santa Monica Native Daughter Cristyne Lawson *by Susan Cloke*



We welcome our new Conservancy Board Member, Cristyne Lawson, the recently retired Dean of the School of Dance at CalArts.

“CalArts decided artists were the best people to run schools. They felt you had to have done it in order to teach it,” stated Lawson, whose dance resume is impressive. “I knew I wanted to be a dancer the day my grandmother took me to Lincoln (Reed) Park for a dance class with a

Ruth St. Denis trained teacher,” remembered Lawson. She went on to study at Juilliard and to dance with the Juilliard Company. Her career included touring with the Martha Graham Company, dancing on Broadway with Alvin Ailey, and touring Europe with the Modern Jazz Quartet. It was in Europe that she met her husband, Graham Smith, an Australian architect and dancer. They were married 19 years, and have two children.

Cristyne Lawson’s mother, Bernice Stout Lawson, grew up in Santa Monica and was a musician. Her father, Hilliard Lawson, was the first black Santa Monica City Council member. The family originally moved to Santa Monica in 1908 when her great-grandmother, Ary Shaw McReynolds, her grandmother, Mary McReynolds Stout, and her grandfather, Rev. Stout, moved into a house next to the CME Church on Fourth Street.

Thinking about her childhood, Lawson said, “I felt there was no place I would rather be. My friends and relatives all lived within easy walking distance. I had a bicycle and could go everywhere in the City. Can you imagine how wonderful it was to have the beach coming right up to the grass? And the Samohi Campus was so open and beautiful.”

Lawson remembers childhood hours spent in the garden of her great aunt’s house on Bay Street near the CME Church. It is now Lawson’s home. “I’m really happy to be back in Santa Monica. I’ve been all over the world, but I love Santa Monica. I hope people will pay attention to our history. I know the City will change, but I hope not too much.”

2011 Preservation Awards

The Santa Monica Conservancy presented its 2011 Preservation Awards at



The Restoration Award

Myra and Earl Pomerantz
2424 Fourth Street

The award was presented for exemplary restoration of their circa-1911 Craftsman bungalow, known as the landmark John and Anna George House. This project pioneered a growing appreciation for historic preservation in Ocean Park in the early 1980s.



Rehabilitation Award

The owners of the historic Edwin Building were recognized for preserving and rehabilitating a small-scale jewel of a commercial building designed by renowned architect Paul Williams in 1928. The building was designated as a city landmark in 2008. The award was accepted by DJ Chomyk on behalf of American Commercial Equities.

This landmark of mid-Century design, designed by Richard Neutra in 1948, had deteriorated significantly over the years. Thanks to Mr. Simon, who rescued and renewed it, the home continues to make an important contribution to the city's architectural heritage.



Annual Meeting

The Church in Ocean Park served as an appropriate venue for the Conservancy's 2011 Annual Meeting on the afternoon of January 23. The historic building, very much an active part of the Ocean Park and Main Street neighborhood for many years, opened its doors to a turnout of nearly 100 members. Reverend Janet McKeithen of the Church in Ocean Park welcomed the group, and a history of the building, researched and written by Karen Corso-Plitt, was available to attendees.

Highlights of the program included the Preservation Awards. "It is very gratifying to see the efforts of so many people giving our architectural heritage new life," said President Carol Lemlein. "By recognizing these accomplishments, the Santa Monica Conservancy holds up these projects as good examples of how historic preservation can contribute to Santa Monica's vitality and attractiveness."

The Board of Directors election resulted in the addition of Cristyne Lawson to the Board (see her Volunteer Profile on page 3), and the re-election of David Kaplan, Sherrill Kushner, Carol Lemlein, and John Zinner to additional three year terms.

President Carol Lemlein then gave an overview of the Conservancy's accomplishments in 2010 and a preview of upcoming issues and events in 2011. (See page 1 for an update on the Shotgun House.) Author and historian Jeffrey Stanton concluded the program with a slideshow of over 100 historic images of the various early twentieth century "pleasure piers" in Ocean Park.

Adaptive Reuse Award

Unitarian Universalist Community Church of Santa Monica
Craftsman Bungalow
The Church was recognized for converting a 1914 bungalow into classrooms and a meeting space for its congregation, choosing preservation and adaptive reuse over demolition and new construction. The Church, located at 1260 18th Street, is also architecturally valuable, having been designed by local architect John Byers in the 1920s. The award was presented to the Rev. Rebecca Benefiel Bijur, Alison Kendall and Keith Ludowitz.

Stewardship Award

Deborah Levin
Hollister Court on Fourth Street
Ms. Levin was recognized for her dedication and leadership in preserving a dozen Craftsman bungalows grouped as a courtyard complex and designated as a city landmark. Since Ms. Levin purchased one of the bungalows 17 years ago, she has worked to save the homes from demolition, protected them from inappropriate remodeling, and provided guidance to other property owners in respectful rehabilitation of the homes.

Outstanding Volunteer Service

In addition to the Preservation Awards, the Conservancy recognized seven individuals for their exemplary volunteer efforts in regularly leading the Conservancy's Saturday morning downtown walking tours. They are: Julie Berger, Winston Chappell, Dorothy Jewel, Kay Pattison, Jerome Robinson, Thomasine Rogas, and Rita Schneir. The popular tour has been in operation since the spring of 2007.

Restoration: historically authentic work to bring a building back to its original condition.
Renovation: includes remodeling and renewing, mixing modern design with work on the historic building.
Rehabilitation: a broad term meaning bringing a building back into service, and for historic buildings, doesn't require strict restoration, but rather conformance with the standards set by the Secretary of the Interior.

Landmarks Commission Report

A Star is Born

Santa Monica has its newest landmark -- the grand home at 2009 La Mesa Drive, designed by renowned Southern California architect Elmer Grey. The 1926 house is a notable example of Period Revival architecture that combines the Tudor Revival and English Cottage styles, an unusual combination in a large-scale home.

The house features a steeply pitched gabled roof, decorative half-timbering, narrow windows with multi-pane glazing, and massive chimneys. It is one of two homes in Santa Monica designed by Grey, the other being the Gillis House at 406 Adelaide Drive, which is also a landmark. Grey was a prolific architect known for his design of the Beverly Hills Hotel, the Pasadena Playhouse, and the Bel-Air Bay Club among many others.

Originally built for A. N. Kemp, a banker, the house is mostly associated with the actress and singer Katherine Grayson, who purchased it in 1945 at the young age of 23 and resided there until her death in 2010.

The home was one of the first to be built on La Mesa Drive after the street opened in 1923 as the centerpiece of the Canyon Vista Tract, developed by the Santa Monica Land and Water Company. It joins three other designated Santa Monica Landmarks along the street: the Zimmer House at 2101, designed and built by John Byers in 1924; John Byers Third Residence at 2034, built in 1929; and the Neimeyer/Strick House at 1911, designed by famed Brazilian architect Oscar Neimeyer in 1964. 2009 La Mesa Drive has recently been purchased by a new owner who is planning a renovation of the house and grounds.

Student Film Competition

Attention middle and high school preservationists and film makers!

The California Preservation Conference will include a short film competition for students. Each film should explore preservation and tie in with the Conference theme "Preservation on the Edge." The conference will address such themes as Community Character, Innovative Practices in Preservation, Economic Development, Sustainability and Future Trends in Preservation.

First prize is \$300. Each film will be evaluated for creativity and artistic merit, content and subject matter, method or equipment used for the project, use of buildings or landscapes, and whether the project is an individual or group effort. Entries will be judged by the California Preservation Foundation and the Young Preservationists. Films can be no more than six minutes long, must be original student work and must comply with You

Tube™ Community Guidelines. The deadline for submissions is 5:00 pm, April 1, 2011.
